## Requirements for Norway Visa

- 1. Original Cover letter**-must be printed from the application portal and signed by the applicant.
- 2.Schengen Visa Application Form**- completely filled out and signed
- 3.One passport sized photo with white back ground** and not older than 6 months
- 4.Photo copy of original passport**- Bio page and used pages(with Visas and Stamps)  
and it should be valid for at least 3 months after departure from schengen area.
- 5.Original Copy of Bank certificate and Bank Statement of the Applicant**-proof of sufficient funds.
- 6.Photocopy of Hotel Bookings/ Accommodations**
- 7.Photocopy of full Itinerary or detailed Day to day activities of the trip**
- 8.Photocopy of Roundtrip Airline ticket Reservation**
- 9.Photocopy of travel Medical Insurance**-Minimum coverage is EUR 30,000/Php2.5M/USD 50,000
- 10.Original NSO certified Birth Certificate of the Applicant plus Photocopy**
- 11. Original Letter of Consent signed by both parents with photocopy of Valid ID with Signature.** (If traveling alone)
- 12.Original Letter of Consent signed by the other parent with photocopy of Valid ID with Signature** (If travelling with only one of the parents)
- 13.Photocopy of court decision awarding custody to that one parent must be submitted** (If only one parent has the sole custody of the child)
- 14.Photocopy of Death certificate** (If the other parent is dead)
- 15. Photocopy of previous passports** (for the past 3 years)
- 16.Original COE**- Position/lenght of Service/Salary/ and duration of approved of leave of absence and **Photocopy of Company ID and Payslip.** ( if employed)

- 17. Photocopy of SEC/DTI/COR/Business permit (if Self employed)**
- 18. Original School Certificate and Photocopy of School ID (If Student)**
- 19. Photocopy of your Marriage Certificate (If Applicable)**
- 20. Photocopies of Birth Certificates of your Children (If Applicable)**
- 21. Photocopy of documentation of own means/properties (if applicable)**
