

REQUIREMENTS FOR CANADIAN VISA

1. COMPLETED APPLICATION FOR **TEMPORARY RESIDENT VISA APPLICATION FORM (IMM5257)**”, COMPLETED APPLICATION FOR “**SCHEDULE 1**”, COMPLETED APPLICATION FOR “**FAMILY INFORMATION**” COMPLETED APPLICATION FOR “**USE OF REPRESENTATIVE**” & **CANADA CONSENT**.
2. **ORIGINAL PHILIPPINE PASSPORT (VALID FOR 6 MONTHS) AND OLD PASSPORTS**
3. **ORIGINAL BIRTH CERTIFICATE AND MARRIAGE CONTRACT (LATEST PSA 2019).**
3. **TWO RECENT PASSPORT SIZED PHOTO**
4. **ORIGINAL BANK CERTIFICATE and BANK STATATEMENT (for 3 months)**
5. **PHOTOCOPY OF PROOF OF ASSETS (LAND TITLES, CREDIT CARD, VEHICLE REGISTRATIONS ETC.) if applicable**
6. **IF EMPLOYED**
 - ORIGINAL EMPLOYMENT CERTIFICATE CONFIRMING YOUR POSITION, SALARY AND DURATION OF APPROVED LEAVE
 - COPY OF COMPANY ID.
7. **IF SELF-EMPLOYED**, PHOTOCOPY OF SEC/DTI ,ITR 1701 ,AND BUSINESS PERMIT
8. **IF STUDENT**, ORIGINAL SCHOOL CERTIFICATE AND COPY OF SCHOOL ID
9. **FOR MINOR**, LETTER OF GUARANTEE.
10. **PROOF PHILIPPINES RESIDENCY (FOR FOREIGN NATIONAL)**
