

REQUIREMENTS FOR IRELAND VISA

- 1. Application Form.** summary sheet with barcode from www.visas.inis.gov.ie signed by applicant
- 2. Original, signed Philippine passport** with at least 6 months of remaining validity. Plus 2 sets of CLEAR photocopies of all passport pages - containing stamps of any kind or visas; blank pages may be omitted.
- 3. Passport-type photographs:** 3 pcs. identical, passport size photographs, taken within previous six months, with white background
- 4. Itinerary.** Day-to-Day Itinerary
- 5. Property papers.** Property papers if possible (land title, business permit, etc.) Optional
- 6. Bank Certificate.** Copies of bank certificate from the bank.
- 7. Bank Statement.** Showing transaction history for the last 3 months
- 8. Tax Return.** Most recent Income tax return.
- 9. Employment Certificate.** A letter from your employer (on business letterhead, with contact details), stating that a leave of absence has been granted and that you will be returning to your current job.
- 10. If you are self-employed,** include a copy of your business license and SEC/DTI copy and income tax return.
- 11. If you are retired,** please submit proof of your retirement fund.
- 12. If you are a Student.** Original School Certificate
- 13. Hotel Reservations.** Copy of confirmed hotel reservations.
- 14. Airline Reservation.** Copy of round trip tickets or confirmed itinerary.
- 15. Marriage Contract.** (If married) NSO copy.
- 16. Birth Certificate.** NSO copy
- 17. DSWD Travel Clearance.** **If the Minor is traveling without the parent/s.**
- 18. Travel Insurance.** An international travel insurance (medical expenses and repatriation) covering the entire period of the person's intended stay and valid for all Schengen states. Minimum coverage should be EUR 30,000.
- 19. Letter of Assurance-** A written undertaking that you will observe the conditions of your visa, that you will not become a burden on the State, and that you will leave the State on the expiration of your permission to remain
