



## FRANCE TOURIST VISA REQUIREMENTS

### 1. Completed Visa Application Form

### 2. 2pcs Passport sized picture (35mm x 45mm, white background)

### 3. Original Valid Passport (old and new passport) with at least 6 months of validity

### 4. Older visas- Photo copy A4 sized paper

### 5. Proof of travel arrangements (round-trip flight reservations)

### 6. Proof of financial (bank statements for the last 3 months, certificate of employment with approved leave of absence, or business registration documents for self-employed applicants)

### 7. Proof of accommodation ((hotel bookings or an invitation letter from a host)

### 8. Flight details

### 9. For minors:

- Birth Certificate
- Application form signed by both parents/ guardians
- Certified copy of IDS / passports of both parents / guardians
- Family court order, in cases where only one parent has full custody over the child - A notarized parental authorization to travel to France, signed by the parents / guardians

### 10. If employed :

- Letter from the employing company plus the supporting documents showing the receipt of salary over the past three months
- Certificate of Employment
- ITR

### 11. If self employed:

- Certificate of business registration
- ITR

### 12. If unemployed:

- Letter of support from the sponsor / guarantor
- Letter from the employing company, or work contract
- Documents showing the receipt of salary the past 3 months for the spouse (husband / wife) - COE of the spouse
- ITR

13. If retired:

- Certificate of retirement or related documents

14. If a student:

- An official letter from the educational institution confirming that the student is enrolled in studies.

15. Travel medical insurance covering at least €30,000 for medical emergencies and repatriation.

16. Birth Certificate (latest)

17. Cover Letter Addressed to the Embassy

18. Proof of ties to the Philippines (e.g., employment certificate, enrollment certificate, property ownership).
