

JAPAN VISA TOURIST REQUIREMENTS

- 1. Original Passport (old and new if you have a previous Japan visa). The current passport must have a signature on the biopage).
- 2. Passport-size Picture (1 piece per applicant). (Must be clear with a white background, formal attire, no teeth showing, or Mona Lisa look.)
- 3. Application Form type written with hand written signatures, printed on A4 sized paper.
- 4. Bank Certificate with ADB (Average Daily Balance) for 6 months. If not state or indicated or state "6months of ADB" if not applicable need to provide additional or a bank statement with 6 months of transactions.
- 5. For employed Individuals:

Certificate of Employment with Indicate Name, Position, Date of hire and Compensation and Original Signature . If the HR signature is an e-signature with must indicate as System generated

If self-employed, provide a copy of DTI Business Registration, SEC, and Business Permit.

- 6. Income Tax Return (ITR) with a handwritten signature. If no ITR is available, provide a Letter of Explanation. Employed Individuals 2306 or 2316 and Business Individuals 1701 or 1701A and COR.
- 7. PSA Birth Certificate issued in 2024 or within the year (check the barcode for the date). If late registration, include Form 137 and Baptismal Certificate, or an explanation letter if these documents cannot be submitted.
- 8. Marriage Certificate issued in 2024 (check the barcode for the date). Authorization Letter with a handwritten signature, printed on A4 sized paper.
- 9. Itinerary and Hotel I will handle this for you.



















10. If Guarantee or sponsor need a Guarantee letter and Affidavit of Support **Notarized**

- 11. FOR STUDENT APPLICANT/MINOR/ NOT IMMEDIATE RELATIVES
- -Notarized Affidavit of Support (Optional for Minor/Immediate Family Member)
- -Original Copy of Birth Certificate (Sponsor and Applicant)
- -Original Copy of Bank Certificate of her parent/sponsor
- -Copy of School ID
- -Certificate of Enrollment Original
- -Parents Photocopy of passport or Senior ID

NANNY/SPONSOR BY EMPLOYER BELOW ARE THE REQUIREMENTS NEEDED

- 1. Original Passport (old and new if you have a previous Japan visa). The current passport must have a signature on the biopage).
- 2. Passport-size Picture (1 piece per applicant). (Must be clear with a white background, formal attire, no teeth showing, or Mona Lisa look.)
- 3. Application Form with handwritten signatures, printed on A4 sized paper. Authorization letter printed on A4 sized paper and Handwritten signature of applicant.
- 4. Bank Certificate with ADB (Average Daily Balance) for 6 months. If not state or indicated or state "6months of ADB" if not applicable need to provide additional or a bank statement with 6 months of transactions. (OF EMPLOYER)
- 5. Certificate of Employment (COE) SEND TEMPLATE FOR COE NANNY
- **6. ITR IF NO (**if no ITR need explanation letter)
- 7. PSA Birth Certificate issued in 2024 or within the year (check the barcode for the date). If late registration, include Form 137 and Baptismal Certificate, or an explanation letter if these documents cannot be submitted.
- **8. Marriage Certificate issued in 2024** (check the barcode for the date).























- 9. Affidavit of Support Notarized FROM EMPLOYER SEND SAMPLE
- 10. PASSPORT COPY OF EMPLOYER
- 11. PROOF OF INCOME OF EMPLOYER (LIKE COE, ITR OR BUSINESS PERSON NEED BUSINESS PERMIT, ITR, SEC, MAYOR'S PERMIT.)
- 12. PROOF OF RELATIONSHIP LIKE PICTURE TOGETHER WITH EMPLOYER
