



## SINGAPORE Visa Requirements for Tourist

- Original valid passport six (6) months from the date of travel
- Duly completed and signed Visa Application Form 14A
- Two (2) recent colored passport size photos with white background, with a matte or semi- matte finish, taken within the last 3 months. Image must show the full face and without headgear (headgear worn in accordance with religious or racial customs is acceptable but must not hide the facial features)
- Copy of Immigration Card (ICARD) issued by the Bureau of Immigration or any proof of residency /immigration status in the Philippines
- Flight itinerary
- Hotel booking confirmation certificate
- Letter of Introduction Form V39A\*

### NOTE:

1. Immigration and Check Point Authority (ICA) of Singapore merely allows applicant to apply the visa thirty (30) days prior to the intended travel date
2. For visa applicants\* who will submit the Letter of Introduction Form V39A - the local contact must be either a Citizen of Singapore or a Singapore Permanent Resident who is at least 21 years old with a Sing Pass/Corp Pass account, supported by their National Registration Identification Card (NRIC).  
Form V39A issued by your Embassy can also be accepted if you are unable to secure a local contact to support your visa application.
3. For visa applicants\* that cannot submit the Letter of Introduction Form V39A, they are required to submit a signed letter of explanation stating the reason for non-submission of the required form.
4. Please submit original and complete documents to avoid delay in the processing.
5. Visa fee and requirements are subject to change without prior notice.

*Commonwealth of Independent States of Armenia, Azerbaijan, Belarus, Kazakhstan, Kyrgyzstan, Moldova, Russia, Saudi Arabia, Tajikistan, Turkmenistan, Ukraine, Uzbekistan, Georgia, India, Democratic People's Republic of Korea, Peoples Republic of China, Holders of Hong Kong Special Administrative Region Document of Identity and Holders of Macau Special Administrative Region (MSAR) Travel Permit*

*\*Afghanistan, \*Algeria, \*Bangladesh, \*Egypt, \*Iran, \*Iraq, \*Jordan, \*Lebanon, \*Libya, \*Kosovo, \*Mali, \*Morocco, \*Nigeria, \*Pakistan, \*Somalia, \*Sudan, \*Syria, \*Tunisia, \*Yemen, \*Holders of Palestinian Authority Passport, \*Temporary Passport issued by the United Arab Emirates and \*Refugee Travel Document issued by the Middle East Countries and \*Titre De Voyage Travel Document*
