REQUIREMENTS FOR BELGIUM VISA

A.General Requirements:

- 1. Visa application form dully completed and signed: https://visaonweb.diplomatie.be/
- 2. Passport with validity of at least 3 months after the end of the planned journey.
- 3. Copy of the data page of the passport together with all pages having visas and stamps;
- 4. One (1) passport sized photo with white background and not older than 6 months; 5. Non-refundable visa application fee to be paid upon submission of visa application;

B. Supportive documents:

Proof of travel

1. Copy of the roundtrip airline ticket reservation with Passenger name & Registration Number (or reservation number). Do not pay for/buy the ticket until a visa has been granted. Note: If the application is approved, the visa will be issued according to your roundtrip airline ticket reservation.

Proof of Travel Medical Insurance:

- 1. Copy of the insurance issued by accredited companies only
- 2. The insurance should:
 - o Have a minimum coverage of 30.000 Euros
 - o Be valid in all Schengen countries
 - o Cover the entire duration of the trip
- 3. Proof of financial means of the applicant:
 - Bank certification, bank books
 - Personal bank statements, credit card statements or balance covering the last six months
 - For minors: Proof of economic means of parents or legal guardian
- 4.Proof of occupation

If employed:

- o Certificate of employment
- o Certificate of leave absence

If self-employed:

- o Department of Trade Industry (DTI)/Securities Exchange Commission SEC registration of business
- o Income Tax Return
- o Business Financial Statement

If student:

- o Proof of enrollment
- o Certificate of leave absence if traveling during school year

If travelling with spouse and/or children

- Marriage contract issued on National Statistics Office (NSO) security paper
- Birth certificates of children issued on National Statistics Office (NSO) security paper

For Minors:

- Affidavit of support & consent of parents (specially of the non-travelling parent) or legal guardian
- copy of passport of parents or legal guardian
- Birth certificate of the minor issued on National Statistics Office (NSO) security paper
- Department of Social Welfare and Development (DSWD) clearance

For non-Filipino applicants who have valid residence status in the Philippines:

- Copy of Alien Certificate Registration (ACR)
- Re-entry permit

C. Documents to submit specifically for Travelling for the purpose of tourism

Proof of accommodation:

Hotel confirmation or hotel voucher

Proof of transportation:

- Copy of train ticket, domestic flight or car rental if planned to visit several Schengen countries

Travel itinerary:

Detailed day-to-day planned trip
