## Applicant under Assessment Level 1 (AL1):

1. Valid passport six (6) months from the date of travel including old passport/s

2. Duly completed and signed visa application (Form 14A)

3. Two (2) recent colored passport size photos with white background, taken within the last 3 months

4. Copy of Immigration Card (ICARD) issued by the Bureau of Immigration or any proof of residency immigration status in the Philippines

5. Flight itinerary

6. Hotel booking confirmation certificate

• Immigration and Check Point Authority (ICA) of Singapore merely allows applicant to apply the visa thirty (30) days prior to the intended travel date

• Letter of Introduction (Form V39A) - the local contact must be either a Singapore Citizen or a Singapore permanent resident who is at least 21 years old with a SingPass/CorpPass account. Form V39A issued by your Embassy can also be accepted, if you are unable to secure from a local contact to support your visa application.

• For AL2 visa applicants that cannot submit the Letter of Introduction (Form V39A), they are required to submit a signed letter of explanation
