REQUIREMENTS FOR APPLYING SOUTH AFRICA VISA WITH PHILIPPINE PASSPORT HOLDER

- 1. Original Valid passport (6 months valid from the date of departure) and Old passports.
- 2. Two (2) passport size photographs with white background
- 3. A fully completed Visa Application Form (BI-84) (must be completed in black ink and block letters)
- 4. Flight Itinerary/Airline Booking;
- 5. Proof of accommodation (hotel booking/address of SA contact)
- 6. Proof of sufficient funds:
 - a. Personal Bank certificate Original (not older 7 days from the time of application)
 - b. Bank statement or certificate (original/certified copy) for at least 3 months;
- 7. If Employed, original Employment Certificate, copy of company ID and ITR 2316;
- 8. If self-employed, provide business documents; (Photocopy)
 - a. DTI/SEC copy
 - b. Business Permit
 - c. COR
 - d. ITR
- 9. Statement and /or documentation confirming the purpose and duration of visit (daily itinerary);
- 10. If coming from or travelling through a yellow fever area prior to arrival to South Africa, a yellow fever vaccination certificate is required;
- 11. Copy of passport (bio-data page) and previous travels.
- 12. Original PSA Birth certificates. Issued 2019
- 13. Original PSA Marriage Certificate. Issued 2019
- 14. Traveling with Minor; Affidavit must be less than 3 months old from the time of application; original should be kept of their records while traveling.

15. Original Cover letter.
