- 1. DS-160 ONLINE NONIMMIGRANT VISA ELECTRONIC APPLICATION (https://ceac.state.gov/genniv)
- 2. Passport. Must be valid for at least six months from the date of intended departure from the United States.
- 3. One 2" x 2" standard photo. Must be white background.
- 4. INCLUDE ALL CANCELED OR EXPIRED PASSPORTS, IF APPLICABLE
- 5. Proof of relationship, if applying with/for dependent/s
- Latest PSA Original marriage certificate (if applying with a spouse and/or child)
- \Latest PSA Original birth certificate (for dependent/s)
- 6. EVIDENCE OF TIES AND FINANCIAL STATUS OF APPLICANT
- > Employment Certificate (If Employed)
- > Enrollment Certificate (If Student)
- > Transcript & Diploma A(If newly grad)
