REQUIREMENTS FOR AUSTRALIAN VISA FOR ALL NATIONALITIES

- 1. ORIGINAL PASSPORT MUST BE VALID WITHIN SIX(6) MONTHS FROM THE INTENDED DATE OF DEPARTURE
- 2. MANAGER'S CHECK OF PHP 5,900.00 PAYABLE TO "AUSTRALIAN EMBASSY" each
- 3. COMPLETED APPLICATION FORM
- 4. TWO(2) PC PASSPORT SIZE PICTURE WITH WHITE BACKGROUND TAKEN WITHIN SIX(6) MONTHS
- 5. NSO COPY OF BIRTH CERTIFICATE (IF APPLYING FOR DEPENDENTS)
- 6. NSO COPY OF MARRIAGE CONTRACT (IF APPLYING FOR SPOUSE & CHILD)
- 7. EVIDENCE OF FUNDS OF THE APPLICANT
 - A) EMPLOYMENT CERTIFICATE (IF EMPLOYED)
 - B) ENROLLMENT CERTIFICATE (IF STUDENT)
 - C) TRANSCRIPT & DIPLOMA (IF NEWLY GRADUATE)
 - D) COMPANY BUSINESS REGISTRATION (IF OWN A BUSINESS)
 - E) ORIGINAL BANK CERTIFICATE AND BANK STATEMENTS
 - F) LATEST INCOME TAX RETURN (ITR)
 - G) LAND TITLES (IF ANY)
 - H) VEHICLES REGISTRATION (IF ANY)

After you finished all the necessary requirements, you will have to have a Manager's Check. You will use it to pay for Visa Fee. And you should lodge your application thru VFS CENTER.
