- 6. Copy of PSA Marriage Contract (If Travelling with Spouse)
- 7. Copy of PSA Birth Contract (If Travelling with Immediate Family or If Travelling Alone)

ADDITIONAL REQUIREMENTS MAY BE REQUIRED BY THE EMBASSY UPON RELEASING OF PASSPORT KINDLY TAKE NOTE THAT ALL DOCUMENTS WILL NOT BE RETURNED EXCEPT FOR THE PASSPORT.
